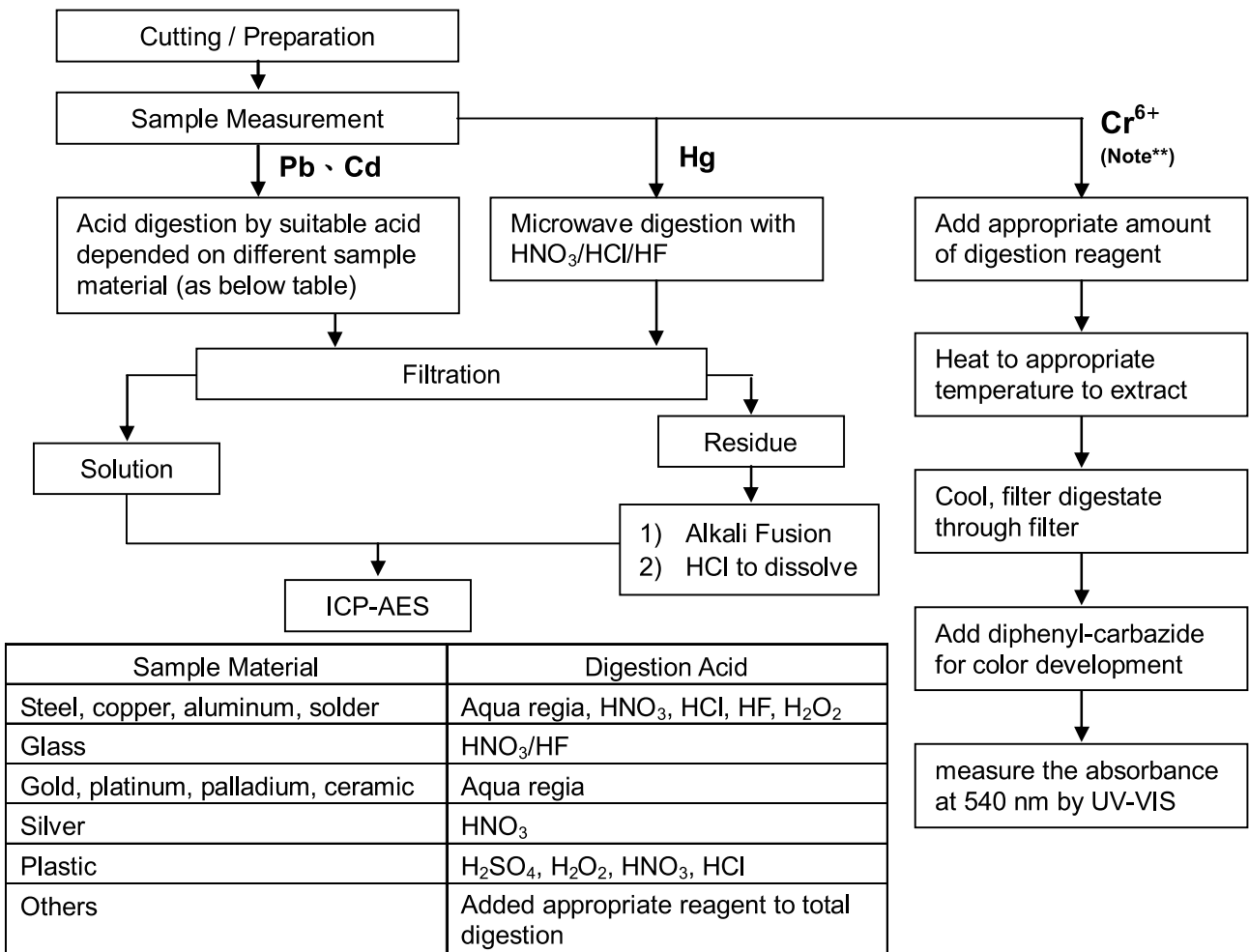

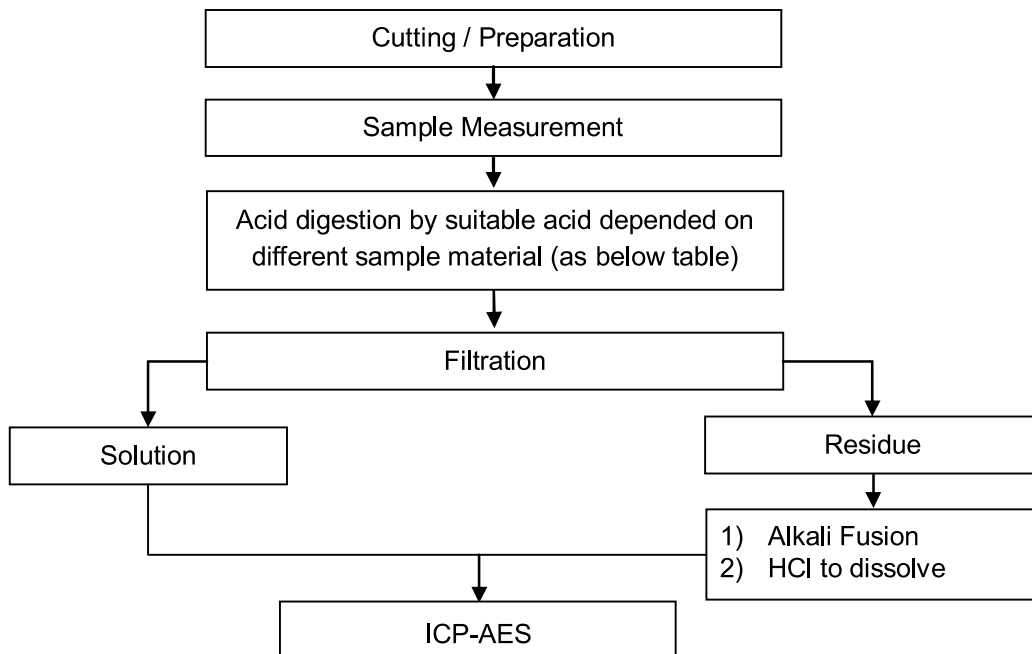

Flow Chart of digestion for the elements analysis performed by ICP-AES

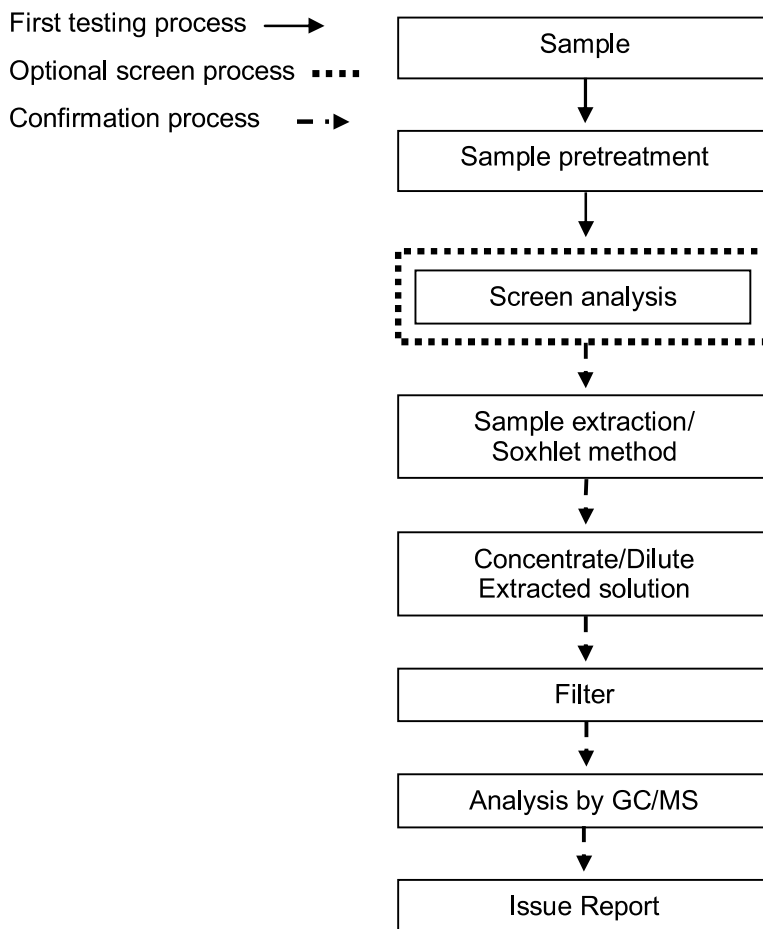

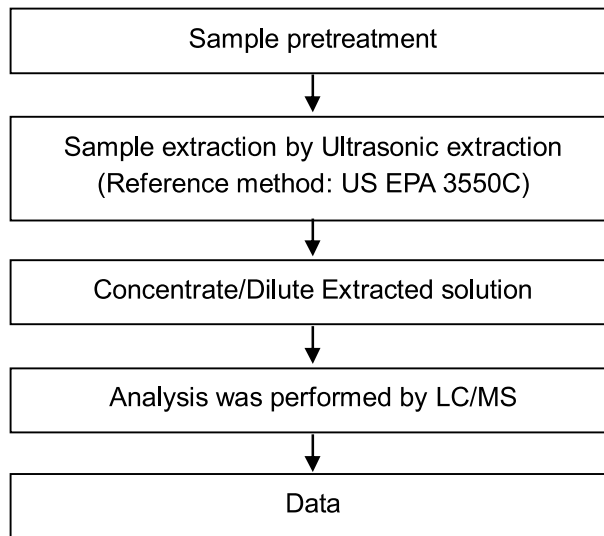

PFOA/PFOS analytical flow chart of Ultrasonic extraction (LC/MS) procedure

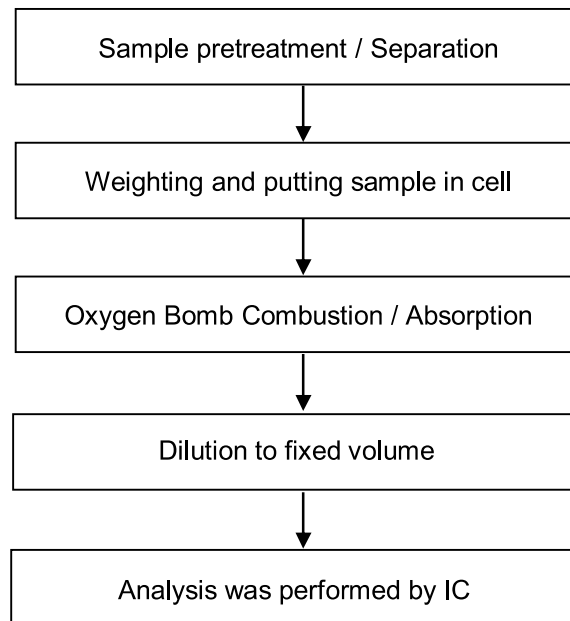

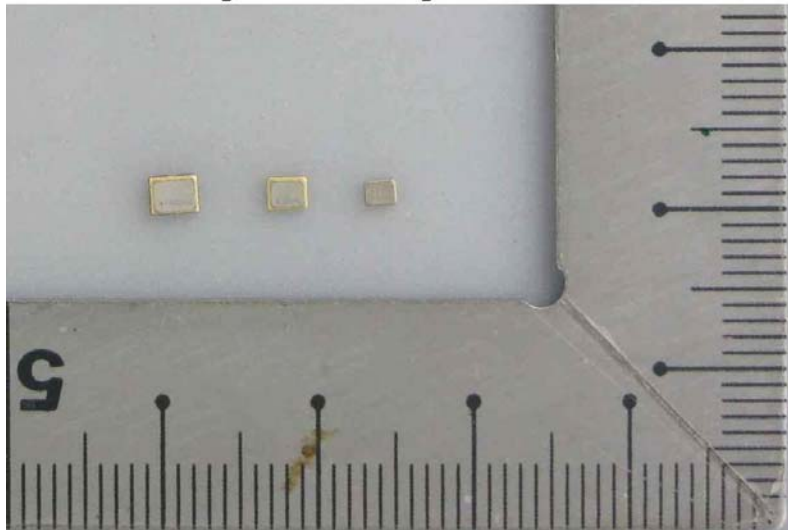

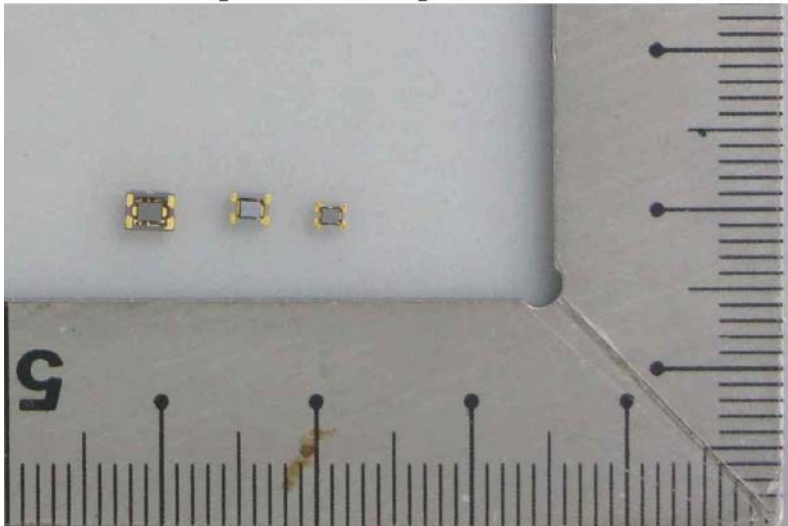
